POLITICAL SCIENCE

Sociology

- Understand one's own society, its culture, institutions, and patterns of interactions. Also understand other cultures, their way of life, elicit views of others and develop and practice 'cultural relativism' as part of their life.
- To sustain macro family culture among the students.

Geography

- Students will get an introduction to the main regions of the India in terms of both their uniqueness and similarities.
